Please see below for more details regarding **Henry Street's** different SYEP contracts and their eligibility requirements.

Henry Street's **Career First NYCHA** contract and **Emerging Leaders** contract are both Special Initiatives. This means that applications for these contracts are first come first serve and **do** <u>NOT</u> **require a lottery.** Additionally, these special initiative contracts are available to youth ages 14-24 years old.

Community Based contracts refer to the general lottery applications that are available to all NYC community members ages 16-21. While Henry Street Settlement does not have a Community Based contract for 14 & 15 year olds, there are over providers available that do.
