

In this document, you can find *Know Your Rights* cards in English, Spanish, French, Arabic, Chinese, and Fulani.

<p>You have constitutional rights:</p> <ul style="list-style-type: none">• DO NOT OPEN THE DOOR if an immigration agent is knocking on the door.• DO NOT ANSWER ANY QUESTIONS from an immigration agent if they try to talk to you. You have the right to remain silent.• DO NOT SIGN ANYTHING without first speaking to a lawyer. You have the right to speak with a lawyer.• If you are outside of your home, ask the agent if you are free to leave and if they say yes, leave calmly.• GIVE THIS CARD TO THE AGENT.
